# "Picture Perfect"

Your great photos need the best paper and ink! By Marilyn Schupp



Paul Dats, the President of Inkpress Paper, presented detailed information about the exciting improvements in inkjet papers and inks that his company is offering to the ar-

tistic and photographic communities. Paul explained that his company has made a great effort to make the best inkjet media, offered at a reasonable price, which will work on most printers to give superior results. He explained that there are lots of companies that coat paper, but a company such as InkPress that makes its own paper and does its own coating will provide the best results. His company offers free downloads of software that allows a person to set up the correct profile for their printer when using different papers and inks. He emphasized how important the correct profile is in achieving superior results.

The goal of InkPress Paper is to provide the end user the quality of the darkroom while maintaining the flexibility of digital. The magnificent black and white prints that Paul passed through the audience left no doubt that InkPress has accomplished this. The large format prints had to be seen to be appreciated. They were amazing!

When InkPress began, they concentrated on producing the finest quality papers and other media. Knowing that the ink you

use is equally important, InkPress became the sole distributor for Jon Cone inks. Jon Cone has been involved in new technologies and improvements to inkjet ink ever since the beginning of inkjet printing. He is a perfectionist and has developed unique products and processes that have elevated inkjet printing to a new level. His products that are available at this time are the Piezography Neutral K7 inks for fine art black and white printing and ConeColor inks for color prints.

The Piezography Neutral K7 inks are 100% pure pigment neutral inks which contain no dye. This means you will have as close to archival quality as possible. Archival quality should have no acid in the paper or the ink to assure the longest life possible for your prints. Jon Cone's system has 7 inks and each is a neutral shade of gray. Use of 7 inks means smoother tonal transitions and dotless prints. The finer particle size of these inks will take advantage of the smaller microchannels found in the Epson print heads. It is possible to use inexpensive Epson printers with special inks and papers and still get top quality results. The Epson 4000, 7600 and 9600 printers work very well.

Paul Dats gave us several tips to help preserve our own special prints. You should use archival paper and inks. For the best results, use papers by InkPress, Konica, Ilford or Epson. Use an ICC profile that is designed for your printer to get the clearest and best image.Paper coated on both sides helps *continued on page 4*

Internet fraud continues to be the fastest growing crime in America (and perhaps the world). The most common technique for fraud today is "phishing." This means that some nefarious person connives you into providing financial account information. They do it by mailing thousands of spam emails to lists of email addresses they have accumulated. Perhaps one of your friends sent a neat joke to 40 acquaintances, including you (your friend's email itself is, of course, spam). Someone out there farms email address. They love it when your friend sends out those appeals and jokes-because they know that every email address they capture (including yours) is current and good. They then send a message like the one below (actually received by the author) to those thousands of email addresses. It matters not if you have PayPal or not. Many of the emails will hit someone who does, and they only need a lot of money from a few suckers to make the effort worth while. Of course, they substitute various bank names for PayPal, too.

Dear valued PayPal® member:

It has come to our attention that your PayPal® account information needs to be updated as part of our continuing commitment to protect your account and to reduce the instance of fraud on our website. If you could please take 5-10 minutes out of your online experience and update your personal records you will not run into any future problems with the online service.

However, failure to update your records will result in account suspension. Please update your records.

Once you have updated your account records, your PayPal® session will not be interrupted and will continue as normal. Go to the link below.

If you already have Office here is a free tool for basic editing of them. This program has been included in all Office releases but is not installed automatically.

If it was not installed then insert the MS Office installation CD and add the Office Tools Photo Editor

To install the program check the box by the program name. If you remove the check from any box, the corresponding program will be uninstalled. You probably do not want to do that.

Following Hugh's presentation we viewed several pictures brought to the meeting on USB Ram drives. This was followed by our routine of questions and comments from those attending.

The first link (to "account records") does not go to PayPal, but goes to <u>www.doctori.biz/pp</u>, a site run by thieves, waiting for you to log in and provide your user name and password for PayPal, or your bank account or other financial service. The login page will look exactly like that of your financial institution. Once you finish "updating" account information, you will be sent to that actual financial site where you can log in and see that everything is in order. The second link (to "Privacy Policy") is a real link to your financial service. It is another part of their smoke screen. But at three o'clock the next morning, there may be some new account activity. The next day, when you log in, you will likely find that everything is no longer in order.

For your internet and financial safety, never respond to an email asking you to check your account. If you are curious, call your financial institution. Also, you can always log in to your account the usual way (not by clicking on a link you receive in an email) and check anything you wish.

A final note: tell your friends to stop broadcasting your email address to the world, to spammers, pornographers, body part enlargers and thieves. Tell them they can comply with your request if they stop forwarding jokes, requests and other such to you and their other friends. Better yet, send them a copy of this article. They deserve it.

prevent humidity from being absorbed by your print. Keep prints in low light and away from the sun, keep them in a cool place and keep the humidity down lower than 70%. Many museums are now starting to display digital images on their walls.

These new products are being embraced by the novice as well as the professional. These improvements to the printing process will be appreciated by anyone using a digital camera or scanner. For example, these archival papers and inks could really be of great benefit to the family genealogist who is trying to preserve their photographic history. One could provide great prints of your precious old black and white family photos by safely scanning them and then printing copies to distribute to your interested family members.

Paul also passed around large format samples of very vivid colorful prints which were printed with ConeColor inks. They were stunning and made a strong impression on our members. Needless to say, we would all like to be able to produce prints like that! InkPress and Jon Cone are driven by the belief that everyone should have access to universal papers and inks to enable them to do high quality printing on their particular printer. They are working hard to make that possible. ConeColor pigment color inks are made with 100% pigment color. They are produced by nano-grinding the pigment to make extremely small particles that have much less tendency for clogging. The inks are archival quality since they contain no dye.

Paul mentioned that InkPress Paper is reasonably priced and is less expensive than Epson paper. InkPress supplies paper in nearly any size you might need, starting with 4x6 and going up to 35x47 inches. They make custom sizes also. You can not buy directly from InkPress. You must buy from the dealers that sell and use their papers and inks. Our closest dealer is Artcraft Camera which is located in the Marshall's Mall on Route 9 in Poughkeepsie. Artcraft Camera offers various types of InkPress paper and can also make prints from your digital file using InkPress paper and Jon Cone inks. Many thanks to Artcraft for donating three packages of InkPress paper to our club drawing and also for giving each attendee 2 sheets of three different types of InkPress paper.

Attendees received 8x10 samples of the Photo Chrome U-Glossy, the Print Plus Matte 80 and the Velvet 250. These papers are compatible with Epson, Canon, HP and other major printer brands. They are water resistant, instant dry, light fast, and acid free. Artcraft sells several types of InkPress paper as well as sampler packages for your experimentation.

The club members in attendance were very appreciative of the expertise and the information provided by Paul Dats and also for the paper packages donated by ArtCraft Camera. You can view the various InkPress Papers on their web site: www.inkpresspaper.com

# The Q and A Session for June 8,2006

Moderated by Dan Sullivan, transcribed by Ray Polivka The Q and A session opened with a discussion of Microsoft's forthcoming operating system Vista. The beta version is now available to the public. Be cautious; do not put it on in place of your current operating system. If you have a second hard drive you could put it on that to play with it there. One should go to Microsoft to see if your system will be able to run Vista. For example, while you will be able to run it with 512 megabytes of memory they are recommending 1 gigabyte. Supposedly a PC made in the last three years will be able to run Vista but it may need more video capacity. Apparently Vista will come in five versions. One should also be aware that if you put Vista on an old machine, Vista will automatically down grade functionality.

Q: I have a dialup XP system. Sometimes the dialup speed is 24k, or 33k, or 36k baud. How can I control that?

A: You can't. The speed depends on conditions at the time of your connection. Hang up and try again. If you want to download something of a fair size, bring your computer to our Upgrade and Repair Sig group at the Guardian Storage building. If your computer is a laptop it is no problem. If it is a desktop just bring the PC and the keyboard and mouse. Our projector can be used as a monitor. Then you can download the material.

Q: On my XP system, I find that SpoolSV.exe is growing from 1 Meg to as high as 20-50 Meg. What is happening?

A: It should not be happening. Perhaps it could be a root kit – a Trojan using that file name to install itself on your computer. You might change its name. Have you done a disk cleanup? Do you have the current updates? (Not sure.) Go My Computerright click on the C Drive-select Properties and click on Disk Cleanup.

Q: I have a new tool. It is called WinaTron. Has anybody used it? It seems like you can analyze your system and tell what is running.

A: No one seemed to have used it. However, Process Explorer, a free download was suggested. It is similar to the Task Manager but it will tell you the name of the companies that own the processes that are running. Going to Google with Process Explorer will get you information about it.

Q: Trying to help a friend with a new computer, he was trying to go to AOL but he could not get the access numbers to go online. The modem was checked and was fine. Using Hyperterminal determined that the signals were getting out so the modem was functioning. Both AOL and MSN, when called, said it was Dell's problem. Finally, I took the computer home and plugged it into my home phone line. Everything worked. It appears that there is something in the phone line not allowing him to go online. I took the computer back and hooked into several of his phone jacks; none of them worked. Yet his phone worked. Checking the phone box outside we found that the ground wire was not attached; it seemed broken. Could that ground wire situation make a difference?

A: It could increase the line noise. The phone company goes to extremes to make sure the phone line is tied to a house ground, which is typically a rod that goes down six feet into the ground. Phones are not as sensitive to noise as computers.

Along that line, someone else was having a lot of trouble with phone noise. The problem was traced back to a corroded phone outlet in a damp area. After cleaning up the socket and the rest, everything was fine.

Q: I have ATT for my e-mail and Optonline. If I go to Optonline and get an e-mail from somebody that has a WMA file, I could not get it to work with Microsoft Media Player. It opens up but won't play. It says that I need some URL. If I go to ATT and open my e-mail it works; it is the same program.

A: There is an incompatibility somewhere. Not working in one place is strange. Go to the URL to see what it says. Try the properties of that message to see if the URL is hidden in the header somewhere.

Q: Every once in a while I will get an e-mail with the outline of an image but it won't bring up the image. I'm using Netscape. I get a red "X".

A: One suggestion was to go to Internet Explorer. However another reported getting the same problem with Internet Explorer. One suggestion was that the ISP has limited the size of the message to be sent. If people send a very large photo it will give the e-mail folk problems. If you are sending pictures with your e-mail, resize the pictures to make sure they are less than a 100K.

(Editor Note: In the June issue of Smart Computing on page 12 the red "X" was discussed. They stated that the red "X" could appear in place of a picture for three main reasons.

1. The Web site's administrator may have moved the image file without an update to the Web's HTML.

2. The Web page's HTML does not include a link to the image.

3. The browser may not be able to display the image.

The first two possible causes have to be addressed by the Web site's administrator. If the browser causes the "X", either the browser does not support the image file type or the browser settings prohibit the automatic loading of image files. In this latter case the magazine offered the following information. In Internet Explorer, Open the Tool menu, click on Internet Options and then go to the Advance tab. Scroll down to the multimedia group and check the Show Picture check box, then OK.

In Foxfire, Open the Tools menu, click Options, and select Web Feature. Then select the Load Images checkbox and follow that with OK.If the Show Picture check box is unchecked, the Web site will load faster. Now when the red "X" appears, you can <u>Right click</u> it and the click the Show Picture to load and view an individual picture.)

Q: If you are using Outlook Express, can you bring in your e-mails all at once and get a table of contents or do you have to bring them in one at a time?

A: There is no reader that lets you look at the mail without bringing it in. The various servers, such as Optonline or Verizon, can give you the names of the messages without looking at them. They are web servers and not a PC mail server. When you look at mail with Internet Explorer you can see the titles of the messages and then choose to open them in a random fashion. If you go to Outlook Express the messages have to come in one at a time.  $\Box$

Les Muldorf was thanked for the interesting articles he has been putting in the Microchip. Articles are due the Thursday after the general meeting every month.


Dan Sullivan reported on the Sig Groups, Upgrade and Repair and Digital Photography.




